Minutes of the meeting of the Planning Committee held on Thursday 24th August 2017 at 8:15pm at the Scout Hut, Perry Hill, Middle Street, Nazeing.

1. Apologies for absence:

2. Public participation:

Cllr Joslin proposed that participation would be included at the appropriate item.

3. Declarations of Interest:

4. Approval and signing of minutes:

The minutes of the meeting of the Planning Committee held on 10th August 2017 were approved and signed by the Chairman of Planning with no amendments.

5. Enforcement Notices/Appeals:

It was noted that no Enforcement Notices/Appeals received since the last meeting.

6. Planning Applications: The following applications were considered:

Applicant Name: Mr John Payne

Location: Lynjon, Nursery Road, Nazeing, Waltham Abbey, EN9 2JE

Proposal: Certificate of lawful development for existing use of the former mushroom farm and paddock as garden land for the parent property.

Resolved - no objection.

(b) Application No: EPF/1956/17 Officer: Graham Courtney

Applicant Name: Mr John Payne

Location: Broxlea Nursery, Nursery Road, Nazeing, Waltham Abbey, EN9 2JE

Proposal: Erection of 4 no. four bed houses and garages.

Cllr Shorter proposed that the Council supports the application. Cllr DiMaria seconded the proposal. Five Cllrs voted in favour of the proposal, one Cllr voted against the proposal. Cllr Clarke asked that her reasons for objection be minuted as the development is in the Lee Valley Regional Park Authority, it does not meet infill criteria and harmful to the openness of the Green Belt.

Resolved – no objection and support the application, as it is in keeping with the street scene and it is an improvement on the current commercial site.

- ii) the property is situated in the Green Belt and conservation area,

- iv) whilst in principle the Council would not object to the four dwellings at the front of the site, the proposal to develop the land at the rear is considered over development.

It was resolved to respond and include details from the comments on the application from Cllrs Skipper & Shorter. Cllr DiMaria requested that the details of the application are forwarded to Lee Stiles (secretary of Lea Valley Growers Association).

8. Update on Matters relating to the Total site. DJ

Cllrs Joslin & Frydrych, Bob Mason (Liquid Living Developments) and representatives from Essex Highways had a meeting on 23/08/17 with the aim of resolving the issue with the Highways Rights. It was ultimately agreed that the Parish Council will submit an application to ECC for the extinguishment of such Highways Rights as may exist. **Action Cllr Joslin / Clerk.**

- **c)** It was resolved to accept the quote of £440 from Vince Cresswell to undertake annual tree and hedge maintenance in the Parish.
- **d)** It was resolved to purchase replacement litter bins for Elizabeth Close play area and Bumbles Green playing field at a cost of £49/bin plus £35 for delivery, giving a total of £280, and for Vince Cresswell to remove the old bins & install the new bins.

10. Communications: The following communications were considered.

a) Harlow Local Development Plan Consultation. Harlow Council are consulting on the Development Management Policies that will help deliver the Plan's Strategic Objectives. The document can be viewed at www.harlow.gov.uk/local-plan. Comments by 07/09/2017.

Unfortunately due to the timescales, ClIrs are unable to respond. It was resolved to ask EFDC & District ClIr Bassett if they have responded and advise that the Parish Council would support them. It was also resolved to ask Roydon Parish Council if they have responded.

- **b)** Thank you letter from RAFA and Royal British Legion. Noted.
- c) Residents have contacted Cllr Skipper as travellers have moved in at Sedge Green. It was resolved to write to Clare Munday (Enforcement Officer at EFDC), stating that the Council believes she is aware of the issue & requesting her to confirm that enforcement action is being taken immediately. It was also resolved to request that no further traveller sites are approved and that EFDC make an application for an injunction against unauthorised Traveller encampments in Nazeing, as recently obtained by Harlow Council.
- **d)** Cllr Clarke advised that a March is being organised in Hoddesdon for 30/09/17 against the incinerator at Ratty's Lane and she will circulate some information.
- **e)** EALC have sent information on their AGM and the ECC & EALC Conference on 19/09/2017 at Dunmow. Cllrs to advise the Clerk by 05/09/17 if they are attending either event. The Clerk will discuss with Chairman and Vice-Chairman to see if they wish to attend.
- **f)** Email received from Mercury reporter regarding the Chimes site, as residents concerned that the site is not secure and potentially safety issues for children accessing the site. It was resolved that it is not a Parish Council responsibility and to forward the information to one of the owners of the site.
